Year to date, we have 6482 incidents entered in the system. Of those, 173 are defined as Bullying or Harassment. Both Bullying and Harassment are considered similar behaviors, as far as federal reporting, but they are labeled separately. Specifically, those labeled as Bullying, total 88. It does seem strange that Burns Middle has so many labeled as such, while the high schools do not. Might be something that needs addressing with the principals.
